CODE OF BUSINESS CONDUCT

1. PURPOSE AND SCOPE

Rubellite Energy Corp. ("**Rubellite**" or the "**Corporation**") has a reputation for integrity and honesty. This reputation has been earned through the unwavering commitment of every employee to these two principles. The continued success of the Corporation is dependent on maintaining the highest standards of business ethics in all interactions with co-workers, shareholders, governments, customers, suppliers, competitors and the public. This Code of Business Conduct sets out a standard of conduct that is required in order to: ensure compliance with laws and regulations that govern Rubellite's business activities, foster Rubellite's reputation in the community and maintain a corporate climate in which the integrity and dignity of each individual is valued and respected.

2. GENERAL

This Code of Business Conduct (or this "**Code**") applies to all directors, officers, employees and consultants of the Corporation. The word "**Employee**", when used in this Code, is deemed to include all directors, officers, full-time and part-time regular employees, consultants and contractors unless otherwise specified.

Rubellite and its Employees will adhere to the highest ethical standards in all business activities. Any situation, decision, or action should first consider what is right and how that situation, decision or action will reflect on the Corporation.

This Code does not specifically address every form of unacceptable conduct. However, each Employee has a duty to preserve and maintain both the letter and spirit of this Code, and it is expected that each Employee will exercise best judgment in applying the Code's guidelines to everyday decisions and actions.

Employees who are uncertain as to the interpretation of this Code, their obligations, or the ethical aspects of any specific situation should consult their supervisor and either the Vice President, Corporate and Engineering Services, the Manager, People and Wellness, or another member of the Executive Leadership Team (collectively "**Senior Management**"), as appropriate.

While working on projects arising from contracts or while working on Rubellite property, it is expected that independent contractors will abide by this Code in the exact same manner as Employees.

Independent contractors should read and interpret all references to "Employee" as being a reference to "independent contractor" for the purposes of interpreting this Code.

3. COMPLIANCE WITH THIS CODE AND ALL RUBELLITE POLICIES

All Employees shall be made aware of this Code upon the commencement of their employment. Amendments to this Code may be made at any time, in the sole discretion of Rubellite, and shall be provided to Employees after such amendments have been approved by Rubellite's Board of Directors.

Compliance with the standards set out in this Code is mandatory and is reinforced through a process of regular certification. Compliance with all of Rubellite's other policies is also mandatory, including but not limited to Rubellite's Controlled Substances Policy, Rubellite's Information Technology Policy, and Rubellite's Respectful Workplace: Anti-Violence, Harassment and Discrimination Policy, compliance with all of which is also reinforced through a process of regular annual certification. Other Rubellite policies for annual review by all Employee's include Rubellite's Artificial Intelligence Policy, Delegation of Authority and Authority Matrix, Discipline Policy, Diversity Policy, Environmental Policy, Insider Trading Policy, GAAR Compliance and Voluntary Disclosure Policy, Mobile Device Policy, Privacy Policy, Safety Policy and Whistleblower Policy.

All Employees are required to certify, upon becoming an Employee and annually thereafter, their review of, agreement to and compliance with this Code, and specifically to Rubellite's Controlled Substances Policy, Rubellite's Information Technology Policy, and Rubellite's Respectful Workplace - Anti-Violence, Harassment and Discrimination Policy, using the certification form attached to this code and/or the specific policy. Such certification form shall also be used by Employees to disclose any business, commercial or financial interests, activities or relationships that might reasonably be regarded as creating an actual, potential or perceived conflict of interest.

Any unscrupulous dealing, any dishonest or unethical business practice, any breach of the law, or any breach of this Code or any other Rubellite policy will be subject to disciplinary action, up to and including termination of employment at the sole direction of the Corporation. Where the conduct in question constitutes a breach of this Code or the Employee's employment contract with Rubellite, such breach will be just cause for immediate termination of employment without notice. Similarly, where the offending party has breached this Code or their agreement with Rubellite, Rubellite may, in the case of a consultant, terminate the consulting arrangement and, in the case of a director, request his or her immediate resignation.

4. COMPLIANCE WITH LAWS AND REGULATIONS

A concern for what is lawfully and morally right underlies all business decisions. A company may be held liable for the wrongful actions of its employees. Employees must therefore be diligent to ensure that their dealings and actions on behalf of Rubellite comply with the requirements and intent of all relevant legislation and regulations applicable in the jurisdictions in which the Corporation conducts its business. This includes rules and guidelines established by self-regulating bodies and professional organizations to which the Corporation or its Employees belong.

Illegal acts by Employees and business associates will not be tolerated. Rubellite Employees will not direct another Employee to violate any law or regulation, regardless of the motive, and an Employee's illegal act will not be excused based on the instructions of his or her supervisor.

In addition to the laws imposed by statute, there is a duty upon a company to honour agreements, whether in writing or not, and to act reasonably and in a manner that will not cause harm to others. Employees must ensure that their conduct is in compliance with this duty.

Ignorance of the law does not typically excuse someone who contravenes the law. All Employees have a duty to themselves and to the Corporation to keep informed of the laws and regulations that may affect their job performance and the affairs of the Corporation, and to share that knowledge with others in the workplace.

5. CONFLICTS OF INTEREST

Each Employee has a duty to act in the best interests of the Corporation. All business decisions and actions taken by Rubellite Employees must be intended solely for the best interests of the Corporation. A conflict of interest occurs when an Employee's private interests in any way interfere, or appear to interfere, with the duties the Employee has to the Corporation.

A conflict situation can arise when an Employee takes actions or has interests that may make it difficult to perform his or her work for the Corporation objectively and effectively, an Employee or a member of his or her family or a friend receives improper personal benefits as a result of the Employee's position with the Corporation, or an Employee or a member of his or her family or a friend has a material interest in an agreement or transaction involving the Corporation. Where a conflict of interest exists or is perceived to exist, the Employee may be put in a compromising position or his or her judgment may be questioned. Rubellite Employees must be, and must be seen to be, free to act in the best interests of the Corporation. Employees must therefore act in such a manner that their conduct will bear the utmost scrutiny -- not only actual conflicts of interest, but the very appearance of conflict should be avoided.

To that end, both at the time their employment commences and at the time a potential conflict arises, Employees must immediately disclose in writing to Senior Management of the Corporation all business, commercial or financial interests, activities or relationships which may reasonably be seen as creating an actual, potential or perceived conflict of interest. The Corporation will then determine if an actual or perceived conflict of interest exists and will decide what steps should be taken in order to protect both the Corporation and the Employee from the particular situation. Resolution may include the Corporation's consent if it is clear that the Employee's interests are not improper, the situation is not adverse to Rubellite and the Corporation's reputation for ethical conduct would not be compromised by the appearance of a conflict of interest. Without the Corporation's written consent to the conflict, the conflict situation must cease immediately.

A director must immediately report to the President and CEO of the Corporation any event that may give rise to a conflict of interest. The potential conflict and any solution thereto will be reported and documented at the next meeting of the Board of Directors. Each director agrees that he or she must refrain from voting on any matter where a conflict exists, and in the event that the conflict is incurable, the director will resign from the board if deemed necessary. Disclosure is also subject to the provisions of the Corporate Governance Directors' Manual, as well as the continuous disclosure obligations set out in National Instrument 51-102, which is incorporated herein by reference.

Many situations may be classified as conflicts of interest. The following examples are not exhaustive, but illustrate those that are most common in order to serve as a guide. Where there is any doubt as to whether

a potential conflict exists, Employees are encouraged to consult with Senior Management of the Corporation.

(a) **Relationships**

"**Family Member**" is defined in the Code as a spouse (including common-law spouse and same sex partner), child, stepchild, parent, sibling, niece, nephew, aunt, uncle, cousin, grandparent, grandchild, in-law (including mother, father, daughter, son, sister and brother-in-law), or any person (other than domestic employees) residing in the same household as the Employee.

The potential for conflict of interest is inherent where an Employee, his or her Family Member, his or her friend gains a personal benefit as a result of a business relationship with Rubellite. The potential for conflict is similarly inherent where an Employee, his or her Family Member, or his or her friend has a relationship with an outside business that supplies, is a customer of, consults to, or competes with Rubellite – in any such case, the Employee will immediately disclose the full nature of the relationship to Rubellite.

Employees shall refrain from giving preferred treatment to a Family Member, friend or acquaintance in the hiring, assessment of performance, career progression, or compensation of such person.

(b) **Outside Business Interests**

Employees shall refrain from:

- (i) serving as director, officer, or consultant of any outside concern which does business with, or is a direct competitor of the Corporation;
- (ii) competing with the Corporation either directly or indirectly;
- (iii) participating in any transaction involving the interests of the Corporation and in which the Employee, Family Member or friend has a personal interest;
- (iv) owning or controlling a significant interest in and participating directly or indirectly in the profits of any outside concern, other than as a regular employee of such concern, which does business with or is a direct competitor of the Corporation; and
- (v) acquiring or trading in oil, gas, coal, or other mineral leases, royalty interests, and production payments that would at the time of their acquisition by an Employee conflict with the best interest of the Corporation;

except with the written consent of the Corporation, which consent will not be unreasonably withheld providing the conflict or potential conflict is not materially adverse to the Corporation.

Further, Employees shall refrain from reserving for themselves or diverting elsewhere a business opportunity that belongs to, has been developed by, is or would be available to the Corporation or for

which the Corporation has been or will be negotiating, or has been discovered through the Employee's use of Rubellite's property, information or position.

Securities of publicly-owned corporations which are traded regularly on open stock markets may be owned by Employees if they are not purchased as a result of confidential knowledge about the operations, intentions or negotiations of the Corporation with such parties or others.

An Employee may hold property or interests acquired by inheritance or from investing for profit in real estate which may incidentally involve mineral interests or leases, provided there is no conflict with the best interest of the Corporation and such holdings were not purchased as a result of confidential knowledge about the operation, intentions or negotiations of the Corporation.

Rubellite Employees are not restricted from participating in other employment, including self-employment, provided it does not conflict with the interests of the Corporation or interfere in any way with the performance of their duties to the Corporation.

(c) Gifts and Payments

It is Rubellite's policy to deal fairly and lawfully with all customers, suppliers and independent consultants purchasing or furnishing goods or services. All goods and services shall be obtained on a competitive basis at the best value considering price, quality, reliability, availability and delivery.

Employees shall neither seek, accept, nor give (directly or indirectly):

- (i) a commission, kick-back, gift or any other fee or payment for the direct or indirect benefit of the Employee or any other persons or corporation;
- (ii) gratuities, gifts or favours of any sort having in aggregate more than a nominal value;
- (iii) loans, cash or securities in any amount, excessive entertainment or travel;
- (iv) payments, services or fees that are excessive in consideration for services rendered in the normal course of business; or,
- (v) special privileges of value, or other substantial or unusual favours;

from or to any person or company which does or is seeking to do business with, or is a competitor of the Corporation and its affiliates.

The above does not preclude Employees from obtaining, on their own credit rating, regular loans from established banking or financial institutions.

Accepting gifts of nominal value (advertising mementos, desk calendars or pens) or accepting hospitality or entertainment (lunch, dinner, or tickets to a local sporting event) is permitted. Employees must discuss gifts of a more substantial nature, such as trips or accommodations, with their supervisor, which in turn

must be discussed with Senior Management of the Corporation. Directors must report gifts of a more substantial nature to the President and CEO.

Modest gifts, favours or entertainment may be provided by Employees whose duties permit them to do so, provided all of the following conditions are met:

- (i) they are not in the form of cash or securities, and are of nominal value (as a guideline, the value should be such that would readily be reported and approved on a Rubellite Employee expense report);
- (ii) they do not contravene any law, are made as a matter of generally accepted practice, and do not create a sense or appearance of obligation; and
- (iii) if subsequently disclosed to the public, they would not in any way harm the reputation of the Corporation or the recipient.

Rubellite complies with all laws prohibiting payments to public officials, including the applicable portions of the U.S. Foreign Corrupt Practices Act.

(d) Social Responsibility and Contributions

As a responsible community citizen, the Corporation encourages and supports the participation of its Employees in political, charitable, educational and cultural activities. However, Rubellite Employees who so participate must do so on their own behalf and in their own capacity, and not as representatives of Rubellite.

The direct or indirect use of the Corporation's funds, goods or services as contributions to charities, political parties, campaigns or candidates for election to any level of government requires the prior approval of the President and CEO.

Contributions include money or anything having value, such as loans, services, entertainment, trips and the use of Rubellite facilities or assets. Time spent on charitable, political or similar activities while an Employee is to be attending to his or her employment responsibilities also amounts to a contribution. No Employee will be reimbursed for any contribution made.

(e) Government Relations

Rubellite offers services to a heavily regulated industry, and in providing services which relate directly to regulations one must be especially sensitive to the interaction of Employees with public officials. All interaction and communications between Employees and public officials are to be conducted in a manner that will not compromise the integrity or reputation of any public office, the Corporation or its affiliates.

Employees shall refrain from engaging in community or political activities in any matter where there may be a conflict with the best interests of the Corporation.

(f) **Directorships**

With the exception of Rubellite directors, directorships by any Employee of any corporation that Rubellite does not control or have an ownership interest in requires prior approval by the President and CEO. As a matter of course, all directorships should be reviewed and disclosed annually as an exemption or potential conflict of interest. It is acceptable to serve on the board of a non-profit, charitable, religious or civic organization without prior written approval (provided it does not interfere with or impair the Employee's ability to perform their duties at Rubellite and represents a commitment of personal time).

6. CONFIDENTIAL AND PROPRIETARY INFORMATION

(a) **General**

An Employee has an obligation to refrain from disclosing to unauthorized persons or using for personal benefit or advantage the Corporation's trade secrets, competitive information, or other confidential, proprietary information which has not been specifically published by Rubellite for external use, and which has not been publicly disseminated.

The Corporation is in a highly competitive environment with other petroleum companies seeking the advantage of technical ideas or information. All Corporation records, information, data, reports, papers, devices, processes, plans, and methods (including but not limited to methods of doing business and information on P&NG rights held by the Corporation, cost information, geological maps, engineering and information system technologies, etc.) are the "**intellectual property**" of Rubellite and are considered to be strictly confidential. In addition, information relating to Employee compensation, including general information regarding Rubellite's compensation, bonus, savings, share ownership, stock option, share-based compensation grants or programs, or benefits plans, or specific information pertaining to individual Employee's compensation, is considered to be confidential information. Employees are not to reveal or use for any personal purpose such confidential information without written consent from the President and CEO.

Confidential information does not include information which is already in the public domain. Certain information may be released by the Corporation (to comply with securities regulations for example); however, the release of such information is a decision of the Board of Directors and/or the Chief Financial Officer and the President and CEO. If there is any doubt as to what can or cannot be disclosed, Employees should err on the side of caution and not disclose any information. For more specific advice, Senior Management should be consulted.

The legal and/or fiduciary obligations of Employees to protect the Corporation's confidential information extends beyond and survives the termination of employment.

(b) **Patents and Inventions**

All inventions, discoveries and copyrights made by Employees during, or as a result of, their employment with Rubellite (where company time, equipment, resources or pertinent information has been used for

personal gain) are the property of Rubellite unless a written release is obtained from the President and CEO.

Rubellite respects the proprietary rights of others as expressed in patents, copyrights, trademarks and industrial design.

(c) Business Records and Financial Transactions

Rubellite's financial transactions are recorded accurately, in a timely manner, and in full compliance with generally accepted accounting principles. Internal controls are in place to ensure that all transactions are approved and executed in accordance with authorities delegated by management, are supported by appropriate and reliable documentation, and are available for independent audit examination. It is expected that all Employees understand their role and responsibilities in this regard. Auditors have access to the Board of Directors, including regular meetings without management present.

Employees must not conceal or defer acting upon knowledge of accounting errors, establish or maintain any undisclosed accounts, or pressure another Employee into making an inappropriate or deceptive accounting entry.

Rubellite has approved and issued a Disclosure Policy that is intended to ensure the Senior Management of the Corporation make timely public disclosure of all material information, including its financial performance, in full compliance with the applicable legislation.

It is a violation of this Code to falsify any Corporation records or documents (including, for example, contracts, orders, time sheets, or expense reports).

(d) Inside Information

Certain information, which Rubellite treats as confidential, may influence the price or trading of Rubellite's shares or other securities if it is disclosed to members of the public. Inside information would include information concerning major contracts, proposed acquisitions, divestitures or mergers, and sales and earnings figures.

Insider trading, which involves the purchase or sale of securities by Employees or their relatives or associates based on inside information regarding the Corporation's affairs, is an improper use of confidential information, is a conflict of interest, and is illegal.

Employees are responsible for being familiar with and abiding by all laws, regulations and rules respecting "insiders" and "insider trading". To assist Employees with their obligations under the relevant legislation, Rubellite has approved and issued an Insider Trading Policy -- Employees are required to be familiar with and abide by this Insider Trading Policy.

Employees who become aware of any information that might be considered "material" have an obligation to immediately report that information to the Disclosure Committee, and not disclose the information outside the Corporation, in order that the committee can determine whether in fact the information is material and therefore requires public disclosure. If any Employee is unsure whether or not information

is material, they should contact a member of Senior Management, or specifically a member of the Disclosure Committee. Refer to the Disclosure Policy for more information as to what type of information may be considered material.

(e) Community & Media Relations

In its business the Corporation and its Employees come in contact with many members of the public, including individuals, community groups, public officials and members of the media. Rubellite strives to maintain its good reputation in the community and, therefore, needs to ensure that Employees speaking on behalf of the Corporation recognize and deal with sensitive issues in an appropriate manner. Enquiries from members of the community related to matters of a sensitive nature should be directed Senior Management of the Corporation. Enquiries from the media should be directed to the President and CEO.

(f) Fair Dealing

Employees shall not take unfair advantage of any customer, supplier, competitor, or fellow Employee through manipulation, misrepresentation of material facts, or any other unfair-dealing practice.

7. PROTECTION AND PROPER USE OF COMPANY ASSETS

All Employees have a duty to protect the Corporation's assets and ensure their efficient use. All Rubellite assets must be used for legitimate business purposes. Employees may not partake in the unauthorized use of Rubellite resources or property, including time at work, for personal benefit or for the benefit of another business.

Rubellite assets include company facilities, equipment, tools, supplies, property (including intellectual property), communication networks, and information systems. Employees are expected to take reasonable steps to protect Rubellite assets from loss, theft, damage, vandalism, gross neglect, unauthorized use or unauthorized disposal, and are expected to safeguard access controls such as codes, access cards, and keys.

Unauthorized use or misappropriation of Rubellite property, networks, funds, or any other asset is not permitted. Examples of actions that are not permitted include:

- (i) misuse of any company-issued credit card;
- (ii) unauthorized use or possession of Rubellite equipment and supplies; and
- (iii) unauthorized use of the long distance network or mobile devices.

Employees are referred to the Corporation's Information Technology Policy, Artificial Intelligence Policy and Mobile Device Policy for further details on the acceptable use of Rubellite's information technology systems.

8. RESPECT FOR OTHERS

Rubellite upholds both the letter and spirit of non-discriminatory treatment and is committed to maintaining a psychologically safe workplace where all Employees are treated with respect and can work free from harassment of any kind, including intimidation, blackmail, ridicule, coercion, or abuse.

Rubellite respects both the law and the spirit of non-discriminatory treatment of employees and co-workers, and is committed to providing a working environment where all employees can work with mutual respect and without fear of personal harassment of any nature, including intimidation, blackmail, ridicule, coercion, or abuse. Behaviours that undermine respect, dignity, honesty, or fairness are inconsistent with this commitment and may constitute harassment or compromise psychological safety. All Employees are expected to conduct themselves in a manner that fosters mutual respect, trust, and inclusion in every interaction.

Any form of harassment in the workplace is unacceptable. Employees are referred to the Corporation's Respectful Workplace - Anti-Violence, Harassment and Discrimination Policy which specifically sets out appropriate guidelines as well as procedures to be followed in the event that an Employee reasonably believes a form of harassment is occurring.

In all matters related to the supervision and development of Employees, including hiring, supervision, compensation, promotion and termination, no Employee will be discriminated against because of race, religious beliefs, colour, gender, gender identity, gender expression, physical or mental disability, age, ancestry, place of origin, marital status, source of income, family status, or sexual orientation of that person or of any other person.

In addition, the Corporation takes modern slavery and our reporting requirements under Canada's Fighting Against Forced Labour and Child Labour in Supply Chains Act very seriously and is committed to ensure that it adheres to such requirements. Accordingly, the Corporation prohibits forced labour or child labour (each as defined under such Act) being used in the Corporation's business and supply chains.

9. HEALTH, SAFETY AND THE ENVIRONMENT

Rubellite is committed to providing safe and healthful working conditions for all Employees, and to conducting its activities in an environmentally responsible manner.

Employees are expected to read and be aware of the Corporation's Environmental and Safety Policies. Awareness of such procedures, and the giving of due regard to all applicable safety standards, regulatory requirements, technical and conventional standards and restraints will assist Rubellite in improving operations, thereby avoiding, to the greatest extent possible, injury or sickness to all persons, as well as damage to property or the environment.

All conditions, situations or accidents which give rise to health, safety, or environmental concerns must be immediately reported to Vice President, Corporate and Engineering Services.

10. EMPLOYEE REPORTING

Rubellite encourages an environment where individuals can confidentially and anonymously report complaints and concerns regarding questionable business conduct without fear of reprisal.

All Employees are encouraged and indeed have a duty to report to Senior Management any behaviour which they believe on reasonable grounds to be disrespectful, unethical or illegal. Reporting may be done on an anonymous basis if the Employee wishes to do so. No adverse action will be taken against any Employee for making a complaint or disclosing information in good faith. Any other Employee who retaliates against someone who has in good faith reported a violation or suspected violation of this Code will be subject to disciplinary action up to and including termination of employment.

Rubellite has also established a Whistleblower Policy, which ensures a safe and secure means by which an appropriate body can receive, retain and investigate all reports of complaints and concerns regarding accounting, internal accounting controls and auditing matters, or any other matter that has arisen from concern regarding breach of any of the Corporation's policies or other matters.

All Employees, as part of their obligation for proper business conduct, are to report anyone they have reason to believe are not in compliance with this Code of Business Conduct or any other policies of the Corporation to the Vice President, Corporate and Engineering Services, the Manager, People and Wellness, or another member of Senior Management or through the means established by the Whistleblower Policy.

11. GRANDFATHERING

Employees who are currently in contravention of any of the requirements of this Code must declare those situations annually. Upon the Corporation's formal approval (which will not be unreasonably withheld), such exceptions will be acceptable providing that the Rubellite's integrity and shareholder assets are not compromised. For example, Rubellite may allow an Employee to be a director of a competitor oil and gas company where no conflict of interest exists.

12. CERTIFICATION

All current Employees of Rubellite and Rubellite's subsidiaries are required, at the commencement of employment and annually thereafter, to certify their review of, agreement to and compliance with the provisions contained in this Code, Rubellite's Controlled Substances Policy, Rubellite's Information Technology Policy, and Rubellite's Respectful Workplace - Anti-Violence, Harassment and Discrimination Policy by completing the attached form of compliance certificate and, in the case of Rubellite's Controlled Substances Policy, the form of compliance certificate attached to that policy. The attached form of compliance certificate is also to be used by Employees to disclose any potential conflict of interest situation that may arise following this certification requirement along with any non-compliance with Rubellite's Information Technology Policy or Rubellite's Respectful Workplace - Anti-Violence, Harassment and Discrimination Policy.

13. POLICIES AND PROCEDURES INCLUDED BY REFERENCE
